## CALL TO ARTISTS Form

Artists are invited to submit up to four original sculptures to Decatur Sculpture Tour (DST). Entries will be critiqued based on artistic merit, public safety, variety of entries, and durability in an outdoor setting. Artists will be notified of the selection committee's decision by Friday, December 15, 2017.

Installation dates are **Thurs., June 7, and / or Fri., June 8, 2018** (the schedule will be set after exhibits are confirmed).

This is a year round outdoor/indoor exhibition. In 2014, a total of 23 exhibits were accepted. In 2015, a total of 25 exhibits were accepted while two exhibits were leased for a total of 27 exhibits on the tour while in 2016, the DST was proud to reveal 31 exhibits. In 2017, the DST Committee looks to continue to offer quality art work in the city of Decatur, IN with 29 original exhibits by 25 artist from 9 states.

Priority will be given to sculptures with broad appeal to audiences of all ages and provide for a variety of exhibits.

The sculptures are owned by the artists and loaned to the program for up to one (1) year. With pre-approval of the artist, all sculptures will be for sale to the public and featured in the Decatur Sculpture Tour brochure. Accepted artists will receive an honorarium (1), stipend for mileage (2), and be eligible for cash awards (3).

Eligibility for awards: Artist must be at least 18 years of age. Submitted sculptures must be original works created within the last three years, suitable for outdoor display and for sale.

Along with **entry form, image/exhibit (sketch) and artist biography / resume.**

Detailed sketches will be accepted as long as support images are provided with the sketches. Please specify whether submitted sculptures are indoor or outdoor. Only one indoor sculpture may be submitted per artist. Awards and allocations in 2018 are likely to be the same or more than in previous years. For artists that meet the application requirements and due dates listed, allocations may be available. For example, in 2017 these were:

- 1: Honorariums: outdoor: first exhibit: \$450 / second exhibit: \$300 / etc. / indoor: exhibit: \$150
- 2: For artists driving 50+ miles one way, a stipend up to \$300 (max) travel allowance will be provided based on \$0.50 per mile from Adams County Courthouse Square, 112 S. 2<sup>nd</sup> St., Decatur, IN 46733. If an artist exhibit is transported by another artist, this allowance is void; however, other terms may be negotiated with DST Committee. Details provided upon request.
- 3: Awards: 2017 awards were: **Best of Show (determined by participating and artists attending the unveiling): \$300 / People's Choice: \$300 / DST Committee: \$150 / Mayor Award: \$150 / Sponsor Award: \$150**
